Immunogen:	Pools of highly purified homogenous IgG2a and IgG2b isolated from rat serum. Freund's complete adjuvant is used in the first step of the immunization procedure.
Format:	<ul> <li>State: Lyophilized purified IgG fraction</li> <li>Purification: Hyperimmune antisera with strong precipitating activity are selected for fractionation and purification of the IgG fraction containing the bulk of the defined antibody specificity.</li> <li>It is free of other serum proteins as tested by immunoelectrophoresis.</li> <li>Buffer System: PBS, pH 7.2</li> <li>Preservatives: None, as it may interfere with the antibody activity</li> <li>Label: Biotin</li> <li>Molar Ratio: Biotin/IgG: ~6.4</li> <li>Reconstitution: Restore by adding 1.0 ml sterile distilled water.</li> </ul>
Applications:	<ul> <li>Can be used:</li> <li>In immunocytochemical and Immunohistochemical staining for the detection of IgG2 at the cellular and subcellular level of appropriately treated cell and tissue substrates.</li> <li>To demonstrate circulating IgG2 antibodies in serodiagnostic microbiology and autoimmune diseases.</li> <li>To identify a specific antigen using a reference antibody of Rat origin known to be of the IgG2 isotype in the middle layer of the indirect test procedure.</li> <li>In non-isotopic assay methodology (e.g. ELISA) to measure IgG2 in rat serum or other body fluids.</li> <li>As a second step an avidin or streptavidin conjugate of the user's choice has to be used.</li> <li>This immunoconjugate is not pre-diluted. Excess labelled antibody must be avoided because it may cause high unspecific background staining and interfere with the specific signal.</li> <li><i>Recommended Working Dilutions:</i></li> <li>Histochemical and Cytochemical Use: 1/100-1/250.</li> <li>ELISA and comparable non-precipitating antibody-binding assays between: 1/2.000-1/10,000.</li> <li>Other applications not tested. Optimal dilutions are dependent on conditions and should be determined by the user.</li> </ul>
Specificity:	The reactivity of the antiserum is directed to the subclasses IgG2a and IgG2b. It does not react with other subclasses of IgG, IgG/Fab fragments, IgM and IgA or any non-Ig protein in Rat serum, as tested by Immunoelectrophoresis and Double Radial Immunodiffusion.

	<b>Cross-reactivity:</b> This immunoconjugate is not species-specific since inter-species cross-reactivity is a normal feature of antisera to immunoglobulins. Cross-reactivity of this immunoconjugate has not been tested in detail.
Species Reactivity:	Tested: Rat.
Add. Information:	<ul> <li>Marker: N-Hydroxysuccinimidobiotin.</li> <li>Conjugation procedure: A proprietary technique for the binding of biotin, followed by several purification steps. After each step activity and specificity are tested in a variety of techniques. The conjugate is lyophilized to assure stability and long shelf life.</li> <li>Adsorption: Immunoaffinity adsorbed using insolubilized antigens as required to eliminate antibodies cross-reacting with other components of the immunoglobulin system or reacting with other serum proteins. Special attention is given to the removal of antibodies to common Ig/Fab. The use of insolubilized adsorption antigens prevents the presence of excess adsorbent protein or immune complexes in the antiserum.</li> </ul>

Storage:

ge:Store lyophilized at 2-8°C for 6 months or at -20°C long term.After reconstitution store the antibody undiluted at 2-8°C for one month<br/>or (in aliquots) at -20°C long term.<br/>Avoid repeated freezing and thawing.<br/>Shelf life: one year from despatch.
