Description:	Recombinant Ovine Leptin Antagonist Triple Mutant is a single non-glycosilated polypeptide chain containing 146 amino and additional Ala at N-terminus acids and having a Molecular Mass of ~ 16 kDa, Leptin was mutated, resulting in L39A/D40A/F41A mutant. Protein content: Protein quantitation was carried out by UV spectroscopy at 280 nm using the absorbency value of 0.21 as the extinction coefficient for a 0.1% (1mg/ml) solution at pH 8.0. This value is calculated by the PC GENE computer analysis program of protein sequences (IntelliGenetics). AA Sequence:
	The sequence of the first five N-terminal amino acids was determined and was found to be <i>Ala-Val-Pro-Ile-Arg</i> . Biological Activity: Recombinant Ovine Leptin-Antagonist Triple Mutant is capable of inhibiting leptin-induced proliferation of BAF/3 cells stably transfected with the long form of mouse leptin receptor. It also inhibits various leptin effects in several <i>in vitro</i> bioassays.
Storage:	Prior to reconstitution store at 2-8°C for one month or desiccated below -18°C. Following reconstitution (at 0.1 mg/ml and up to 2mM and Filter sterilization) store undiluted at 2-8°C At lower concentration addition of a carrier protein (0.1% HSA or BSA) is suggested. Avoid repeated freezing and thawing. Shelf life: one year from despatch.
