Storage:

The antibody can be stored at 2° - 8° C for 1 month without detectable loss of activity. Antibody can be aliquotted and stored frozen at -20° C to -70° C in a manual defrost freezer for six

months without detectable loss of activity. Avoid repeated freeze-thaw cycles.

Application Notes

Western Blot: Only tested for Western using Recombinant mouse Neuregulin-3

Immunohistochemistry: Antiserum was used on fixed tissue.

This antibody can be used with the appropriate secondary reagents to detect Neuregulin-3 on tissues dissected from animals that were fixed by vascular perfusion with 4% paraformaldehyde/PBS (pH 7.4) and followed by perfusion with a 10% sucrose solution in 0.1 M phosphate buffer (pH 7.2).
