Storage: Antibody can also be aliquotted and stored frozen at -20° C to -70° C in a manual defrost freezer for

six months without detectable loss of activity. The antibody can be stored at 2° - 8° C for 1 month

without detectable loss of activity. Avoid repeated freeze-thaw cycles.

Application Notes

Immunohistochemistry

This antibody will detect Cathepsin B in cells and tissues. The working dilution is 2 - 15 µg/mL.

Western Blotting

This antibody can be used at $0.1 - 0.2 \,\mu\text{g/mL}$ with the appropriate secondary reagents to detect mouse Cathepsin B. The detection limit for recombinant mouse Cathepsin B is approximately 20 ng/lane under non-reducing and reducing conditions.
