The naturally occurring form of 14-3-3 gamma in which the N-terminus Met is removed and the Val is acetylated is not recognized by this antibody. Other species have not been tested.

**Immunogen Sequence:** N-terminal fragment of human 14-3-3 gamma

**Format:** 0.1 ml Mouse ascites.  
Concentration of 6.8 mgs/ml

**Applications:** Western blot-1:1,000

Dilutions listed as a recommendation. Optimal dilution should be determined by investigator.

**Storage:** Store frozen. Aliquot as undiluted antisera and immediately place at -20°C. Antisera may have become trapped in top of vial during shipping. Centrifugation of vial is recommended before opening. Stable for at least 6 months at -20°C. Repeated freeze/thaw cycles compromise the integrity of the antiserum.

This antibody is specific for human 14-3-3 gamma.
