Description:	Recombinant murine SCF produced in E.Coli is a single, non-glycosylated polypeptide chain containing 164 amino acids and having a molecular mass of 18309 Dalton. The SCF is purified by proprietary chromatographic techniques. Format: rmSCF is supplied as sterile filtered white freeze-dried powder. It was lyophilized from a concentrated (1 mg/ml) solution in water containing 10 mM Sodium phosphate buffer pH = 6.5 . It is recommended to reconstitute the lyophilized rmSCF in sterile 18M-cm H2O not less than 100 $\mu$ g/ml, which can then be further diluted with other aqueous solutions. Protein quantitation was carried out by: 1. UV spectroscopy at 280 nm using the absorbency value of 0.52 as the extinction coefficient for a 0.1% (1 mg/ml) solution. This value is calculated by the PC GENE computer analysis program of protein sequences (IntelliGenetics). 2. Analysis by RP-HPLC, using a standard solution of SCF as a Reference Standard. <b>Molecular weight:</b> 18 kDa
Storage:	Lyophilized Mouse SCF although stable at room temperature for 3 weeks, should be stored desiccated below -18°C. Upon reconstitution rmSCF should be stored at 4°C between 2-7 days and for future use below -18°C. For long term storage it is recommended to add a carrier protein (0.1% HSA or BSA). Please avoid freeze-thaw cycles. Shelf life: one year from despatch.
